# Training

HNC Civil Engineering – SVQ level 3 (SCQF Level 7)

### **Working Hours**

Working hours will be in accordance with the requirement of the role but will, as a guide, be Monday to Friday 07:30 to 17:30 with requisite breaks.

Due to the nature of our business, working hours may be subject to variance to ensure effective execution of duties and successful completion of critical time sensitive activities.

Maximum of 40 hours per week if you are under 18 years old.

#### Remuneration

Proposed salary is **£negotiable depending upon relevant experience.** Wage reviews are conducted annually.

### **Probationary Period**

The company operates a standard 3 month probationary period, during which either party have the right to immediate termination of employment.

### Holidays
